#### "Did You Know...? - Street Parking"

Did you know...that street parking in our association is governed by the California State Vehicle code? It's true! Our streets are not "private". California's basic street parking law states that all cars parked on our streets must be, "parked with the right-hand wheels of the vehicle parallel with and within 18 inches of the right-hand curb." Many of the cars parked on our streets violate this at times and could be subject to a ticket as a result. Especially worrisome is the practice of parking "head in" at the end of our cul-de-sacs. This is not only illegal, but also unsafe as it creates issues for emergency vehicles and cars that may not be able to navigate easily at the end of these streets.

#### Here's a brief list of parking situations that are NOT legal:

- · Head-in parking at the end of cul-de-sac streets
- · Parking on the "opposite" side of the street (right hand tires must be parallel to the right hand curb)
- · Parking farther than 18 inches from the curb
- Parking in your driveway but letting your car block the public sidewalk

We will be paying closer attention to this and partnering with the City of Concord to help alleviate parking issues and make our neighborhood safer.

#### ARCHITECTURAL COMMITTEE

The Architectural Committee would like to thank those who have removed the unsightly weeds from their lots. We would also like to thank those who removed ivy and shrubs/bushes blocking sidewalk access as well as tree branches blocking lights & street signs. Those of you who have not done so, may receive an Architectural Notice in the mail to remove said weeds, branches, etc. Please note the tone of the notice while informative may be interpreted as threatening, this is NOT the case. It is merely conveying information the Association is told to include in said letter. Should you need more time to correct said notice the AC encourages fellow homeowners to contact General Manager, Pat Magee in the Business Office at 925 687-9961.

Along with our focus on the unsightly weeds; the AC will also take note of the following: tree branches blocking street lights, street signs, and hanging lower than 8 feet from the sidewalk and 12 feet above the street. Also, bushes, shrubs and ivy that are blocking sidewalk access or view and all painted exterior surfaces such as base, trim, fascia boards, balconies, garage doors and beams. The AC will also focus on fences. You may have noticed many of our homes have fences in need of replacement. We are aware of this, too and are constantly citing them.

And wait for either an approval, approval with conditions or denial. Please note, a denial could be that more information is requested. This includes, but not limited to, removing trees, painting house, replacing driveways, replacing front lawns and/or fences, and replacing windows. #### **View From The Clubhouse**

As the CHOA sponsored events come and go I've noticed a marked improvement in rsvp responses. This is something I want to thank the vast majority of you on. Not only are most of your rsvp's coming in before the deadline, they are also coming in with the necessary information... first/last name, address, contact number, and the number in your party. When directions are followed it makes it so much easier to plan accordingly. So, thank you all very much! With that said, out of the original 125 RSVPs there were 33 no-shows. This is an ongoing problem that the Board is taking under consideration moving forward towards the next CHOA sponsored event in September.

I thought this would be the ideal time to reiterate Clubhouse Rental Requirements as some renters are not clear on the process. Number 1: You MUST submit your \$500 Security/Cleaning deposit to secure your rental date. If you do not, your tentative date is in jeopardy of being given to someone else. Number 2: You MUST fill out the Rental Contract in its entirety. That means signatures where required and initials where required. Number 3: All required forms, fees, paperwork MUST be turned in at least two weeks prior to your event. If not, there is a chance you will lose your rental date. Number 4: There is a site walkthrough form that the Clubhouse staff and you MUST perform before AND after your event. I advise taking pictures of the items you think might cause you trouble later on. You do not want to be blamed for something you did not do. Number 5: If you rent a certain area of the Clubhouse you are NOT allowed to use any other part (i.e: Game Room and/or Kitchen). If you do you will be charged. Thank you for abiding by the rules and policies set up to make your event go smooth and worry free.




