- Crossings Challenge Fees: next year it will be increased another \$2/swimmer which ends up being a \$5 over 2
  vears.

#### Boosters: (Tess Wendler & Erin James)

- Age group events: today was 11/12 event at Cowell Pool; 9/10's camp out 7/19/16. Camp out is optional, some
  families can go home after the activities or camp at the greenbelt. CHOA offers to provide pizza for this event. 6&U
  has activity the Friday prior to Crossings Challenge.
- Coach appreciation week July 25-29
- Family fun night- (7/27/16) We will empty out what's left in kitchen.
- City Spirit week Aug 1-5. Our Dance will be Weds. 8/3/16 at 6-8pm. Fun events planned during practice that week.

#### Fundralsing:(Robin Lewis)

- Coach Adrian recommends that the swim-a-thon during practice next year. Robin to meet with Adrian to discuss ideas for next year.

#### Meet Director:(Tony Washmera)

- Jobs overview: Families are not signing up for jobs or not showing up. Tony working on this and recommendation that the specific families get emails from Tony/Matt McCloskey, swimmers will not be allowed to swim if parents not signed up or don't show up.
- DCSL- need two non team logo pop ups for over grand stands. Tony and Matt McCloskey or Eric Oberbruner to help set up.
- Sue and Data team trying to trouble shoot as to why the system crashed at SSC meet, but just in case we have 18 new stop watches for back up.
- Signing in for invitationals-reminder email to go out again. EXCEPT for CROSSINGS CHALLENGE and CITY
   MEET which will be a sign out because Adrian is trying to encourage more numbers.
- Adrian to Tony Washmera- all league meets we should be notifying coaches of DQ slips within 30 minutes of DQ.
   DQ info needs to be added to coaches meeting prior to meet. May move announcer closer to starter(under scoreboard) so the DQ slips can be announced right away.

#### IT Director:(Alyse Lustig)

- End of Year survey will be sent out to WCST committee first before going out to team.
- Invitationals- seed times are not the most up to date so some families are confused about whether their child pops or not. Adrian can run a "best times" report, we could publish that on our website.
- In "documents" section, Alyse to clean it out and delete the meet programs and keep meet results.
- Swimmer of the Week will continue this Weds night meet.

#### **Head Coach:**

- WCST took 1st place at Devil Mountain Pentathalon! (Alyse to submit article to Signal)
- Coaches reviews due by August
- Fall clinic to be advertised at Crossings Challenge and City Meet and the team website link to Eagle Rays.
- Adrian working with some kids who do not have any B times and cannot participate in Crossings Challenge to put together a cheering section.

## **Directors:(Matt McCloskey)**

- Robin Lewis for Matt Dobbs: Wants name change from Meet Director Elect to Meet Director Assistant, and Director Elect to Director Assistant. Reason to change: If a director wants to stay longer than one year they are not forced out. The concern is that at some point we could have both director and director assistant leave at the same time. Per Donna Glover: following Robert's rule of order-a term has to be determined. Adrian recommends that whomever takes over for a director is someone that has served on the committee in any capacity so that they have context, then you don't need a director elect. Robin recommends that if a director wants to stay on they could put their name on the ballot to be re-elected. Jackie Byrd feels it is very important to have a person groomed for the two major jobs-Director and Meet Director.
- Plan to rotate the job title(elect, director) but the job is the same vs run every year and the assistant is there if director leaves.
- Donna Glover recommendation: If Meet Directory Elelct position is vacated at end of the year the board can appoint someone for Meet Director(which is what Meet Director Elect would have gone into it.) Then end of year election would elect Meet Director Elect.
- SOP is work in progress.
- Crossings Challenge-there will not be a food truck, too expensive. Other vendor agreements are in the works.
