EAST POOL GRAND OPENING!

After several months of construction, the East pool project is coming along swimmingly and despite the wet weather, is still set to open on Memorial Day weekend, Saturday, May 26th. The Board and Management would like to help celebrate the grand reopening with a complimentary BBQ next to the pool. Board Members will be there cooking up hamburgers and hot dogs and providing drinks for all residents who attend. Remember to bring your ID badges and your new key fob as those are both required to use any of the pools.

MORE POOL NEWS!

Along with the newly renovated East pool, the West Pool is also set to open up on Memorial Day Weekend, Saturday May 26th. Neither of the side pools will have a stationary lifeguard and will work like they did last year, with the head lifeguard checking in periodically and residents using the sign in binder located just on the inside of the main door.

Currently the Walnut Country Swim Team has exclusive access to the Main pool from 3-8PM Monday through Fridays for their preseason practice. This means that during those times the main pool is closed off to residents. They will keep on the afternoon schedule until June 11th. On that Monday they will switch over to early morning practices from 7AM until noon, allowing residents to access the pool during the hotter hours of the day.

TIPS FOR PROPER HAZARDOUS CHEMICAL STORAGE AND DISPOSAL

Take a quick check in your garage, or shed, and you'll likely find an assortment of chemicals, solvents, paints, pool chemicals, automotive products, pesticides, cleaners and many other common household items that we seem to collect over time. The key question; are they stored properly, out of reach of children, and in the proper containers?

A general rule, chemicals should be always stored in their original container. If you are moving chemicals like paint or solvents, always be sure to read the label and store according to the manufacturer's instructions, and label correctly. Location is also important, as many times chemicals are stored in a garage where the water heater is often located. Many chemicals are highly flammable and must be kept a safe distance from a flame (pilot light). When possible, store out of reach of children or invest in an approved locking chemical storage cabinet. Children and pets are often the casualty of improper storage. Proper safety practice can prevent accidental poisoning.

Disposal of old chemicals? Did you know....?

Contra Costa County has a free Household Hazardous Waste Collection Facility located in Martinez. The facility is open to residents of Contra Costa County Central with proof of residency. This free service is easy to use, simply load you vehicle and drive to the location and they will unload everything for you.

THE ARCHITECHTURE COMMITTEE IS WATCHING

Part of living in a homeowner association means that you need to abide by certain rules about the upkeep of the outside of your home. This is for the benefit of all. These rules are enforced by the Board following inspections by the 8 volunteer homeowners who make up the architecture committee. Every month they check all 1,062 homes, ensuring that they meet the Community's high standards, before meeting to review their inspections and approve or deny architectural applications.

Each month close to 100 letters are mailed. The most common problems are unkempt lawns, unregistered or inoperable vehicles, and fading/peeling house paint. If you do find yourself on the receiving end of a "courtesy" letter, and you're not sure why, give the business office a call and someone will be available to explain it to you.


