NEW BUSINESS / ACTION & DISCUSSION ITEMS

Item: Basketball Court Usage & Signs

Following up on the discussion at the April 22nd, 2021 Board meeting, the Board further discussed the reported issues of alleged non-residents and inappropriate behavior at the common area basketball courts. The discussion centered around the installation of signage around the basketball courts reminding residents of the Association rules.

A motion was made and seconded to approve the language and design of the sign as presented by management, and to delegate authority to Director Kindorf to determine the installation location, number of signs to be installed, and approve all costs associated with this project. **The motion carried unanimously.**

The final approved design of the sign has been appended to these minutes.

Item: Pool Chemical Controller Upgrade Proposals

A motion was made and seconded to approve the following pool chemical controller upgrade proposals as presented by Sun Pointe Services:

- Proposal #2207 in the amount of \$2,499.04 to install an upgraded Intellichem Commercial Controller at the East Pool
- Proposal #2208 in the amount of \$7,177.61 to install an upgrade Intellichem Commercial Controller at the Main Pool and Wading pool, as well as a new dual pump system for the Wading Pool.

The motion carried unanimously.

- Keep music at a reasonable level
- Pick up all trash when leaving
- No alcohol or glass containers a: allowed on or near the courts

- Play is limited to 30 minutes when others are waiting
- When multiple groups of different age groups are present, half court games are encouraged
- CHOA staff or security personnel have the authority to eject any individual found in violation of these guidelines
